Explanation of Responses:

- Represents deemed disposition of shares of Class A common stock to the Issuer to satisfy tax withholding obligations in connection with the vesting of restricted stock units.
- Each performance-based restricted stock unit ("PSU") represents a contingent right to receive one share of Class A common stock.
- These PSUs vested on February 28, 2025, upon the achievement of certain service-based and performance-based vesting conditions.
- PSUs vest based on the achievement of (i) service-based vesting conditions that are satisfied in five equal installments on the 36, 42, 48, 54 and 60 month anniversaries of the grant date and (ii) performance-based vesting conditions that are satisfied upon the achievement of closing stock price hurdles for 20 out of any 30 consecutive trading days equal to \$12, \$13.50, \$15 and \$17, in each case prior to the sixth anniversary of the grant date.
